# **Georgine Milmine Collection - Scope and Content Notes**

The Georgine Milmine collection documents research, writing, and correspondence related to a series of articles about Mary Baker Eddy that appeared in *McClure's Magazine* from January 1907 to June 1908. The collection also contains material related to the 1909 biography by Georgine Milmine titled *The Life of Mary Baker Eddy and the History of Christian Science*. The collection also contains later correspondence and memos related to the purchase and subsequent handling of the papers by The First Church of Christ, Scientist.

The bulk of the collection dates from 1903 – 1909, during the research, writing, and publication of the original *McClure's* articles. The early years primarily document the preparation of the articles, and the later years document public reaction to the articles, both favorable and unfavorable. There exists the possibility that some of the research material included in Milmine's notes was actually prepared prior to 1903 by Frederick W. Peabody, but no outside verification has yet been made. A subset of the collection dates from the early 1920s and is concerned with the acquisition and organization of the collection. The total date range of materials is 1903 to1930.

The organization of the collection follows, roughly, its original order as documented in a June 1920 inventory made by employees of The First Church of Christ, Scientist, following the Church's purchase of the papers. The inventory is included in the collection and items that have been moved are marked. There are ten subseries, each containing a type of record as grouped by the original inventory.

The records are in mixed physical condition. The bulk have some wear at fold lines and edges, and are yellowed, but in otherwise good condition. Some papers have deteriorated further, and the scrapbook of clippings is in average condition. All items have been copied for public use. The majority of the collection is unique to this location; some memos exist in multiple copies, and Milmine's typed selections from Eddy's writings exist in published form. There are no restrictions on use of the collection.

The collection was generated primarily by Georgine Milmine as she set out to write a series of articles about the life and work of Mary Baker Eddy. In this pursuit, she took extensive research notes, both from library work and from personal interviews, kept a clippings file of newspaper articles, collected photographs, and retyped passages from Eddy's published writings. She eventually turned her research into drafts of articles, none of which seem to bear any resemblance to the final published articles. Her work also sparked a great deal of correspondence involving Milmine, various *McClure's* editors, and individuals writing to express approval, disapproval, or offer more information about Eddy.

# **Biographical Notes**

## Adams, Georgine Milmine Welles (1874-1950)

Georgine Milmine was born in Ontario, Canada, in 1874. According to most accounts, she was inspired by Ida Tarell's reporting on Standard Oil in *McClure's Magazine*, and decided to write about Mary Baker Eddy in a similar fashion. She spent a number of years (most likely 1903 - 1906) interviewing and researching for the articles, and turned in her materials as well as early drafts to *McClure's*, after which her involvement with the project was limited. The articles were largely rewritten by staff editors.

Milmine worked for a time on the staff of the *Syracuse Herald*, editing its women's pages, and married its managing editor, Benjamin Welles, on August 22, 1905. She moved with him to Auburn, New York, when he became an editorial writer for the *Auburn Citizen*. Welles passed away in 1911 and Milmine married Arthur A. Adams, a prominent druggist in Auburn, on August 24, 1914. References indicate that she continued as a newspaper and magazine writer, but no other work of hers has ever surfaced. Milmine and her husband moved to Falmouth, Massachusetts in 1937, and Milmine passed away on August 27, 1950, three weeks before her husband.

## Cather, Willa (1873-1947)

Willa Cather was born in Virginia, and moved to Nebraska with her family when she was four years old. At one time she wanted to become a surgeon, but after she graduated from the University of Nebraska, she began writing for newspapers following a lively undergraduate literary career.

After some time in Pittsburgh, she accepted an editing job at *McClure's* in 1906; in 1908 she became managing editor, and stayed in that position until 1912, when her first book – *Alexander's Bridge* – was published. Subsequently, she wrote books and short stories full time, and was an extremely accomplished and prolific writer; her most famous works, such as *My Antonia, O Pioneers!*, and *Death Comes for the Archbishop*, all deal with life in the American West, and often have semi-autobiographical elements. Cather passed away in 1947, at the end of a long and distinguished career.

# Hendrick, Burton J. (1870-1949)

Born in New Haven, Connecticut, Hendrick attended Yale University, continuing on there to receive his master's in 1897. After graduation he went to work for the *New Haven Morning News*. Within a few years, he had moved to New York and was writing for a number of publications such as *The New York Evening Post* and *The New York Sun*. In 1905, he was hired as a staff writer at *McClure's*, where his most prominent work was an exposé titled "The Story of Life-Insurance." In September 1912, Hendrick wrote an article for *McClure's* titled "Christian Science Since Mrs. Eddy," calling on his earlier involvement in editing the Milmine series.

In 1913, Hendrick left *McClure's* to serve as an associate editor of *World's Work*; in 1919, he struck out on his own as an extremely successful biographer. He received the Pulitzer Prize in 1921, for *The Victory at Sea*; in 1923, for *The Life and Letters of Walter H. Page*; and in 1929, for *The Training of an American*. He continued on to write several "group" biographies of businessmen and politicians, and was working on a biography of Louise Whitfield Carnegie, wife of Andrew Carnegie, when he passed away.

# Irwin, Will (William Henry) (1873-1948)

A graduate of Stanford University, Irwin worked for a number of newspapers including the San Francisco Sun, the New York Sun, and then as an editor of McClure's Magazine from 1901-1907. He won acclaim for his coverage of the San Francisco earthquake of 1906, and was a war correspondent for the Saturday Evening Post during the First World War. He later wrote plays, novels, and corresponded extensively with Herbert Hoover. Irwin was married to the feminist author Inez Haynes Irwin (who published as Inez Haynes Gilmore) from 1916 until his death.

# Peabody, Frederick W. (1862-??)

Peabody was born in Brooklyn, New York, and attended the New York Polytechnic Institute, then Columbia University. He received a law degree in 1888, and after passing the New York bar, moved to Boston. There, he married Anna May, daughter of a prominent Boston family; their marriage was a tumultuous one that ended in divorce in 1908 after several court cases and accusations that he had stolen and spent his wife's inheritance.

In 1899, Peabody was hired by Josephine Woodbury to prosecute a libel suit against Mary Baker Eddy. What began as a simple attempt to earn money and fame seems to have turned personal, and Peabody spent the rest of his life fighting bitterly against Eddy and Christian Science. He delivered the lecture *A Complete Exposé of Eddyism or Christian Science: The Plain Truth in Plain Terms Regarding Mary Baker G. Eddy*, then published his talk as a pamphlet in 1901. He delivered further lectures on the same topic, and went on to write two more books.

From 1906-1907, he corresponded with Georgine Milmine and Willa Cather, and a portion of the research and testimonies they used to write the *McClure's* articles seem to have come from him; he probably introduced them to many of the individuals they interviewed. Many of the accusations and assumptions he used in his lectures and writings re-appear in the *McClure's* articles.

In March 1907, Peabody joined in the "Next Friends" suit against Mary Baker Eddy as a junior counsel. He was in fact a moving force behind the entire suit, which accused Eddy of being incompetent to manage her affairs. The suit was dismissed in October 1907. Peabody remained in contact with Eddy's son George Glover, and was involved in the suit to contest Eddy's will in 1911.

# **Georgine Milmine Collection – Folder Descriptions**

The Georgine Milmine collection is largely preserved in the original order in which they were received when purchased by The First Church of Christ, Scientist, from a New York manuscript dealer in June 1920. The records were later grouped into ten series, as below:

The item numbers included in each folder reflect the original inventory of the collection, made at the time of purchase.

Unless otherwise noted, materials are undated.

## Series I. Scrapbook – Items 36-39

Newspaper clippings from 1903-1906, bulk dates from 1903-1904. Christian Science related clippings.

# **Series II. Inventory and General Information**

#### 168 Inventory of Papers

Original inventory made by staff of The First Church of Christ, Scientist, most likely at the time of the acquisition of the collection in June 1920. The inventory has many later pencil notations by Archives staff, mostly indicating where items from the collection were moved — e.g., to the Subject File, photograph, or pamphlet collections.

#### 168 Research Notes I

This folder contains three sets of research notes made by Georgine Milmine: notes on Mark Baker (copied from records at the Tilton Congregational Church), P.R. Russell, and George A. Quimby. All sets of notes are undated.

#### 168 Research Notes II

This folder contains further research notes made by Georgine Milmine. The first, "News from Tilton: Mrs. Philbrook and Mrs. Baker, Etc." contains notes on Mrs. Tilton, Daniel Patterson, J.H. Bartlett, John Clark, Mrs. Baker, Mark Baker, Asa Eddy, and others. The second, titled "Quimby's Subjects: Quimby's family" includes several letters to Milmine as well as notes on Phineas P. Quimby. The second two sets are interviews: "Interviews from Rumney," with interview notes on Wayland Herbert and Abbie Merrill, and "Interviews Dresser, and Warren Felt Evans," contains notes on Warren Felt Evans, Annetta Seabury Dresser, Julius Dresser, and Horatio Dresser. Most items in the folder are undated, but there are some items dated from 1905-1907.

# 168 Statements RE: McClure's Collected by Alfred Farlow

This folder contains letters, statements, notes, and affidavits collected by Alfred Farlow to refute information contained in the Milmine articles. Among the correspondents are Janet Colman, Julia Bartlett, Ellen Clark, and Caroline Noyes. Except for the occasional undated item, all material dates from July 1905 to March 1907.

#### 168 Miscellaneous Research - Items 41-46

This folder contains further research notes made by Georgine Milmine, mostly of the "official" kind: notes from the Library of Congress on copyright, a deed of trust, and a death certificate. Also included are copies of previous biographical articles about Eddy, including one by Septimus J. Hanna published in the October 1896 issue of *The Granite Monthly*. Most material is undated; dated material ranges from June 1882 to December 1906.

#### Series III. Affidavits and Interviews

#### 168 Affidavits and Interviews - Items 47-53

This folder contains further research notes made by Georgine Milmine, mostly interview notes, with one affidavit and some basic notes. The interviews are mostly undated, and conducted with Ebenezer J. Foster Eddy, Frederick W. Peabody; the affidavit was written and signed by Henry F. Dunnels, and the notes are on Dr. J.W. Winckley. Dated items range from April 1907 to September 1907.

168 Affidavits and Interviews - Items 54-59

This folder contains further research notes by Milmine and others. There are also several affidavits collected by Frederick W. Peabody. The research notes are mostly on collected groups of individuals from Lynn and Stoughton, as well as an interview with Peabody and a collection of notes titled "Regarding Science and Health."

168 Compilation of Letters, Testimonies, Information - Item 60

This folder contains notes on interviews and interactions with various people who knew Eddy; most of the notes are probably Milmine's, but at least one is signed F.W.P. - Frederick W. Peabody. Among the individuals researched are Richard Kennedy, Julia Russell Wolcott, and Arthur T. Buswell. There are also notes on subjects such as "Lynn," and "The Spofford Conspiracy."

168 Affidavits and Interviews - Items 61-69

This folder contains dozens of short testimonies and affidavits from people who claimed to have had some contact with Eddy. It also contains research notes, probably by Milmine, in short sentences, mostly concerning the organization and running of The Mother Church. The only dated material in the folder is from November 1903.

169 Extracts from the Journal - Item 70

This folder contains notes made on various issues of *The Christian Science Journal*, both general research notes and transcribed portions of articles. They date from the *Journal*'s founding in April 1885 to October 1904.

Affidavits and Interviews - Item 71: Copies from Court Cases

This folder contains typed notes and unofficial copies of legal documents related to a variety of court cases that involved Eddy. Most notably, materials from the Spofford and Kennedy lawsuits are included, as well as the divorce proceedings related the dissolution of her marriage to Daniel Patterson in 1873. Materials range in date from August 1872 to March 1907.

#### Series IV. Letters

#### 169 Letters - Items 72-82

This folder contains copies of miscellaneous letters written to and by Eddy, some verified (against original copies in the Library's collection) and some unverified. Most relate to the editing and publication of Christian Science periodicals. Additionally, there are letters to Milmine (here Mrs. Welles), newspaper articles and an anonymous note about spiritualist communication. The material dates from September 1864 to January 1907.

#### Series V. Miscellaneous Items

#### 169 Various Research Materials - Item 83

This folder contains research notes in at least three different hands, one of which is Milmine's, on Richard Kennedy, the Wentworth family, Clara Choate, Josephine C. Woodbury, mesmerism, the history of Christian Science, and miscellaneous other topics. All undated.

#### 169 Various Research Materials - Items 84-90

This folder contains miscellaneous items such as an address by Augusta Stetson, typed research notes on mesmerism, a copied extract from a novel by Balzac, and handwritten notes and materials about E. J. Foster Eddy and his adoption process, written by Milmine. All materials are undated.

#### 169 Various Research Materials - Items 91-94

This folder contains typed research notes, presumably by Milmine, on newspaper articles and advertisements from the *Banner of Light*, and the *Lynn Weekly Reporter*, as well as a letter from Lyman Powell to Willa Cather and a speech by the "Hon. Reverdy Johnson" calling for the abolition of slavery. Materials range from April 1864 to July 1907.

# 169 Material Connected to Spofford Case - Item 95

This folder contains mostly retyped clippings from newspapers on the Spofford case, as well as miscellaneous notes, flyers, and statements. Materials range from January 1878 to February 1879, with many undated.

169 Material on Barry Case - Item 96

This folder contains retyped newspaper clippings on the Barry case, as well as fragments of notes on the case. Items date from September to October 1879.

170 Woodbury vs. Eddy-Witness List - Item 97

This folder contains a list of witnesses in conjunction with *Woodbury v. Eddy*, organized by theme (i.e., "Partially Friendly Testimony) by the note-taker (presumably Milmine). Each witness has an address listed, and many have short explanatory notes fleshing out their testimony. Material is undated, but internal evidence strongly suggests it is contemporary to the original case, and possibly assembled by Frederick Peabody at the time of the case, c. 1901.

The next three folders contain the court transcript of proceedings in *Woodbury v. Eddy*, with witness testimonies and statements made in court before Judge Bell and a jury. The transcripts are dated May 29, 1901. (Pages 13-25 are missing from the first folder.)

This folder contains excerpts from a rough draft of *The Life of Mary Baker Eddy and the History of Christian Science*, interpolated with research notes and outlines for other sections. There are only very occasional handwritten edits, most likely either Milmine's or Cather's. The material appears to have little to no resemblance to the final published book, and is undated.

This folder contains dozens of letters written to Georgine Milmine with information about Eddy. Among the writers are Martha Rand Baker, Richard Kennedy, and Hannah Philbrook. Some are copies of letters present in other folders, especially in Box 171. The letters date from June 1904 to March 1908.

#### 174 Various Research Materials - Item 110

This folder contains letters written to either Georgine Milmine or *McClure's* with information about Eddy; some of the letters are duplicates of those contained in previous correspondence folders in Box 171. Among the writers are Alfred Farlow, Frederick Peabody, and Arthur Buswell. Letters are dated from January to April 1907.
